

All qualifications are recognized by the Bar Standards Board in the UK as well as the Legal Profession Qualifying Board of Malaysia, which conducts the Certificate in Legal Practice (CLP) examination.



MUET: Band 4

SPM / O-LEVEL: 3Cs in any subjects (In one sitting)

AND any of the following in one sitting A-LEVEL: Minimum 2Ds in one sitting

UEC: 5Bs (Required to have MUET Band 4)

AUSTRALIAN YEAR 12 / SACE International / NSW HSC / AUSMAT: Minimum ATAR of 50

CANADIAN PRE-U: Passes in 5 subjects of at least 50%

STPM: Minimum 2 principal passes (Including General Studies) from Grade C and above,

in one sitting (Required to have MUET Band 4)

Minimum CGPA of 2.5 needs to be satisfied.




